### TERMS OF CONTRACT

- The Mobile Services under this Agreement are provided by Telguard Ltd. Telguard is a limited company incorporated in England and Wales whose registered office is at Orchard House, 39 Gatwick Road, Crawley, West Sussex, RH10 9RB. Telguard Ltd solely supply Commtel Ltd with SIM card services to support the Commtel range of products. Commtel Ltd are a door entry and access communications manufacturer whose products are approved by the Network Providers for Connection to their Networks. Commtel Ltd and Telguard Ltd share the same ownership and are located at the same address.
- This is a 12-month Contract, payable in full prior to activation of the SIM and is non-refundable for early termination.
- The SIM provided will remain the property of Telguard Ltd for the 12-month period.
- Whilst the SIM remains the property of Telguard Ltd during the agreement period – the SIM is specifically allocated to the serial number of the unit. If the SIM is removed from the allocated Commtel product and used elsewhere without prior notification, this breaches the Contract with Telguard Ltd and the SIM may be barred/ceased.
- Contracts will not renew automatically, and you will be contacted 2 months prior to the end of the contract period with your renewal offer. If you no longer wish to continue with the SIM once the Contract has ended, the SIM will be ceased. Each renewal is subject to the Terms and Conditions ruling at the time of renewal.
- We have a fair use policy in place. Should this be exceeded, Telguard Ltd have the right to terminate the Contract.
- Both Telguard Ltd and Commtel Ltd cannot be held responsible for any third-party charges resulting in the use or abuse of the product.
- All reported faults will be responded to within 48 hours Monday to Friday.
